The meeting of the Battlefield Fire Protection District Board of Directors was called to order by Chairman Walt Newman at 6:00pm. Stormy led us in prayer and then the pledge of allegiance was recited. A roll call was taken and a quorum was established. Derek moved to accept the agenda with amendment for closed session. Darrell seconded the motion and all approved. Ron moved to approve the minutes. Darrell seconded and all approved.
