Board members present: President Trevor Crist, Darrell Decker, Walt Newman, Derek Fraley and Kregg Keltner were present.

The meeting of the Battlefield Fire Protection District Board of Directors was called to order by President Trevor Crist at 6:00pm, Chaplin Stormy Davis led the prayer and then the pledge of allegiance was recited. A roll call was taken and a quorum was established.

Darrell moved to approve the agenda. Derek Seconded. All voted Aye Darrell moved to approve the January minutes. Walt Seconded. All voted aye.

# Financial Report:

Darrell requested approval of the financials, payment of bills and signing of checks.

Darrell discussed January's financial report and review of assets. Battlefield Volunteer Fire Department total liabilities and revenue equal \$4,306.70. Battlefield Fire Protection District total liabilities and revenue equal \$2,866,485.07. Statement of net Assets; ICS \$4,170,161.41, and Money Market \$47,604.95. Darrell advised he visited with the Auditor on February 7th the adjustment for the final December statement will take place with the completion of the audit. The equipment reserve amount will not change. The remainder will be set into the building reserve. Darrell advised projected tax revenue is at 81.95% for the year. Darrell called attention to line item 4085 a new budgeted revenue line for EMT Courses offered by the District, projected revenue is \$25,000.00. Attention called to line item 6110 the work comp expenditure. Darrell advised this was paid out as it is at the first of the year.

Darrell moved to approve the financial statements. Derck seconded, All voted aye,
