The meeting of the Battlefield Fire Protection District Board of Directors was called to order by President Trevor Crist at 6:00pm. Deputy Chief Scott Moore led the prayer and then the pledge of allegiance was recited. A roll call was taken and a quorum was established.

# Financial Report:

Darrell requested payment of the bills, approval of the financials, and to sign checks.

Darrell discussed the financial report and review of assets. Battlefield Volunteer Fire Department total liabilities and revenue equal \$4,284.29. Battlefield Fire Protection District total liabilities and revenue equal \$1,532,194.23. Statement of net Assets; ICS \$2,744,115.53, and Money Market \$26,802.87. All accounts have been reconciled. The allowance for restricted funds is now matching. Revenue for the year is on par. The year's expenses are on track per budget.
