

Board members present: Walt Newman, Ron Smith, and Darrell Decker were present. Trevor Crist and Derek Fraley were absent.

Others present: Chief Newberry, Deputy Chief Reynolds, Deputy Chief Moore, Battalion Chief Shawn Crump, Chris Sidebottom, Ed Kaiser, Christopher Mumm, Chance Mitchell, Ben Choate, Kasey Strong, Chris Ellis, Greg Smith, Dustin McHaffie, and Kevin Newton.

The meeting of the Battlefield Fire Protection District Board of Directors was called to order by Chairman Walt Newman at 6:03pm. Ed Kaiser led us in prayer and then the pledge of allegiance was recited. A roll call was taken and a quorum was established.

Darrell asked for agenda item By-Laws be removed due to Derek and Trevor being absent. Darrel then motioned to approve the agenda. Ron seconded the motion and all approved.

Ron moved to approve the minutes from the February meeting, Darrell seconded and all approved.

Darrell requested to pay the bills, approve the financials, and to sign checks. Darrell discussed the financial report. The statement of cash flow shows \$424,376.62 received as tax revenue. Then review of assets. All items have been reconciled. Darrell requested to close all U.S. Bank accounts. This was previously agreed by the board allowed. All accounts will reside with Oakstar Bank. Darrell motioned to approve financials for the District and the Volunteer Department Ron seconded the motion and all approved.

Unfinished Business:

Deputy Chief Reynolds discussed the Station 3 project. Brick work has started and the KNOX key box has been ordered. All items of concern have been sorted out.

Deputy Chief Moore had no updates on the new apparatus.

Return to work policy is being worked through by staff. This is still in draft format and being vetted by worker's compensation and legal counsel.

New Business:

During the overview the Board was briefed on the Secretary Interview process. 14 applicants, 9 interviews. Look to bring a name for approval in April.

Chief Officers updated the Board of an ongoing grievance process with Local 152.
 The grievance is expected to go to a review board in accordance with step 3 of the Grievance Process.

Ron moved to reopen the meeting. Darrell seconded the motion and all approved.

The meeting was reopened at 6:44pm and Walt announced no votes or actions were taken during closed session.

Ron moved to adjourn at 6:44 pm.
