Ordinance 13.004

Under the powers of the Board given by Missouri State Statutes 321.220, the Board of Directors have on this date adopted the following Fire Protection and Fire Preventions Ordinance.

Each official, officer or employee or candidate of the district will disclose in writing the following transactions if any such transactions occurred during the calendar year.

- a. For such person, and all persons within the first degree of consanguinity or affinity of such person, the date and the identities of the parties to each transaction with a total value in excess of five hundred dollars, if any that such person had with the district, other than compensation received as an employee or payment of any tax, fee or penalty due to the district, and other than transfers for no consideration to the district.
- b. The date and the identities of the parties to each transaction known to the person with a total value in excess of five hundred dollars, if any, that any business entity in which such person had a substantial interest, had with the district, other than payment of any tax, fee or penalty due to the district and other than transfers for no consideration to the district.

The chief administrative officer and chief purchasing officer of the district shall complete and have on file with the district a "Financial Disclosure Statement for Political Subdivisions" obtained from the Missouri Ethics Commission.
