Minutes Regular Board Meeting

Board members present: President Trevor Crist, Darrell Decker, Walt Newman and Kregg Keltner were present. Derek Fraley was not present.

The meeting of the Battlefield Fire Protection District Board of Directors was called to order by President Trevor Crist at 6:00pm. Chaplain Stormy Davis led the prayer and then the pledge of allegiance was recited. A roll call was taken and a quorum was established.

Darrell moved to approve the agenda with the amendment to move Edward Jones 457b ahead of Financial Business. Kregg seconded. All voted aye.

Walt moved to approve the August 8th Board Meeting Minutes with the date correction. Kregg seconded. All voted aye.

Darrell moved to approve the August 30th Special Meeting Minutes. Walt seconded. All voted aye.

New Business:

Mr. Tony Reahr, the districts Edward Jones representative presented 457b options due to changes that are occurring within the Lord Abbott Company. Options were presented to the board. No decisions made.

Financial Report:

Payment of bills and signing of checks has taken place.

Darrell discussed August's financial report and review of assets. Battlefield Volunteer Fire Department total liabilities and revenue equal \$5,326.27. Battlefield Fire Protection District total liabilities and revenue equal \$969,948.33. Statement of net Assets; ICS \$2,107,981.51, and Money Market \$51,824.54. All accounts have been reconciled. Reserve accounts are matching. The District is 67% thru the year. Darrell called attention to Line Item 6530 Election expense. This line has over budgeted due to additional fees from Greene County. Line Item 6640 has been

created for the Roth IRA section for 457. This is a line that the same as the 457. Darrell advised move funds are likely to be moved to line 7300 from building reserve before the end of the year. No move at this time.

Darrell moved to approve August's financial statements. Kregg seconded, All voted aye.

Unfinished Business:

Chief Newbery advised that the number of employees that are contributing over 7% to the 457b plan. This will impact 25 employees. The Social Security Administration is awaiting a rule on the vote. They will handle the education and election. Discussion took place.

Walt Moved to allow the employees to vote on the Social Security contribution through the State Social Security Administration. Kregg seconded. All vote aye.

Deputy Chief Moore advised no new information in regards to the Aerial. Deputy Chief Reynolds advised the financing (RFP) deadline is September 29th for the Aerial.

Deputy Chief Reynolds advised he contacted the architect in regards to the estimated cost of Station 4 Remodel. The estimated construction remodel cost is \$450,000.00. Discussion took place.

General Overview:

Chief Newberry advised the Labor Management meeting is September 26th at 10:00am.

Deputy Chief Moore introduced new Firefighter Chris Keim to the Board.

Deputy Chief Moore advised the Incident Support Team Trailer will be housed with the district, likely stored at Station 2.

Closed Session:

Kregg moved to go to closed session per RSMo 610.021 (3) and (13). Darrell seconded and all voted aye. Meeting closed at 7:12pm. Roll call was taken: Board Members present: Darrell Decker, Trevor Crist, Walt Newman, and Kregg Keltner. Derek Fraley was not present. Also present: Fire Chief Bryan Newberry, Deputy Chief Scott Moore, and Samantha Forir Secretary for the Board.

Walt moved to go back into open session at 7:30pm.

Roll call was taken; President Trevor Crist, Darrell Decker, Walt Newman, and Kregg Keltner, were present. Derek Fraley was not present.

President Trevor Crist advised the approval of the hire list took place.

Chief Bryan Newberry tendered his resignation. Chief Newberry's last day will be October 13th, 2017.
